Research Update

Ohiwa backdune trials

Monitoring is continuing on a native species planting trial at Ohia Beach, eastern Bay of Plenty. The trial was planted in mid-2005 by the Whakatohea Trust, the Ohia Beach Coast Care group, Environment Bay of Plenty, Opotiki District Council and Ensis. The trial is comparing the performance of 12 coastal species planted on a relatively stable backdune site. These include tarakupenga, taupata, ti kouka, toetoe, akeake, koromiko, pohuehue, ngaio, tauhinu, harakeke, karo and houpara. For each species, survival and growth of seedlings raised in Tinus root trainers are being compared with those raised in the larger PB planter bags. Early results indicate significant differences in species preferences in three planting zones from weed-infested landward sites to more exposed open sites located seaward. The trial will be fully assessed in mid-2008 and a report prepared for the Dune Restoration Trust.

Dune reshaping trial completed

The final report for the foredune reshaping and planting trial at Oakura Beach, south-west of New Plymouth is completed. The trial was established in mid-2000 as a collaborative effort involving the New Plymouth District Council, Oakura Coast Care Group, Taranaki Regional Council and the Coastal Dune Vegetation Network. Planted native sand-binders successfully established a dense cover on the reshaped dune trapping sand for the first two years. In subsequent years, the entire beach sustained severe erosion. However, re-contouring of the foredune and planting with native sand-binders did not contribute to, or exacerbate erosion of the foredune.

Based on the results from the Oakura trial, the New Plymouth District Council have implemented an ongoing reshaping and planting programme along the northern coastal suburbs of New Plymouth over the last four years. Re-contouring and planting mainly spinifex and pingao at East End and Fitzroy beaches has seen significant trapping of sand. Foredunes have coped well with effects of occasional storms. While at an early stage, reshaping and planting appears to have obviated the need to continue the substantially more expensive option of armouring the beaches with rocks.

Petone and Eastbourne dune trials

Rosie Doole of Hutt City Council was successful in obtaining support from the Sustainable Management Fund of MfE to build coast care partnerships in two harbour-side communities in Wellington. This includes establishing various planting trials to replace marram-grass dominated dunes with native species appropriate for these localities. Ensis has been contracted to assist in establishing community-based dune planting trials using both sand binders and back dune coastal species. The first backdune trial has been established along one section of the Petone beach and further trials will be established in the next few weeks.

International Conference on Sand Dune Restoration

Santander Spain was the location for the inaugural International Conference on Coastal Dunes, held in early October. Harley Spence, Mark Dean and Dr. David Bergin wrote a paper about the formation and building successes of the Dune Restoration Trust (formerly the CDVN).
